Auditors' report and call for an Extraordinary Delegates Assembly regarding annual accounts of the years 2018 - 2023

Dear Ermes, dear EMF board members,

on behalf of the auditors (Germany and Sweden) I send to you the auditors' report regarding the audit of the annual accounts 2018 – 2023 including attachments. As discussed in the Delegates Assembly 2024 in Croatia we now call for an extraordinary Delegates' Assembly in June 2026 before the ordinary one in August to elect new auditors and to give them the chance to finish the audit in time. The goal is to give a new vice president finance the chance to start after an election in August without tasks from prior years.

Attached you find 4 letters of 4 member nations regarding 13.2 of the statutes ("*...at least 1/10 of the number of active members can affect or demand the convening of an extraordinary Delegates' Assembly.*")
